Letter to the Editor

I am writing to express my concern at the decline in the hardiness of the Club. Two particular events show this:

### ILLEGAL USE OF CYANIDE

Recently six of us from the Club did a Sunday trip onto the Ngamoko Range in the Ruahines, going up Knights Track. We found cyanide poison and flour bait laid on the track and adjacent farm land. The poison was spaced at 50 meter intervals right up the middle of the track!! Since this stuff is highly lethal we decided to inform the Forest Service about it. They were pleased that we brought this to their notice, apparently this line was illegally laid and the Forest Service are trying to find out who did it.

Usually cyanide paste is placed with a small pile of flour, sometimes flavoured with jam etc, often at the base of trees. The poison works by the cyanide paste reacting with moisture and releasing cyanide gas – deadly poison.

There are a number of legal requirements and Forest Service policies that have to be obeyed when persons use cyanide for opossum poisoning. Some of these are:

1. Up to date signs must be near the poisoning area and tracks.
2. The cyanide bait must be laid off the side of tracks.
3. The used cyanide paste tubes must not be left lying around.
4. Users of cyanide paste must have a permit from the Forest Service.

So if you ever see any doubtful use of cyanide please let the Forest Service know. Also beware of unusual tubes, this or other material, or odd smells in/or near huts or elsewhere.

# BILL PUTS NATIONAL PARKS IN JEOPARDY!

## The Threat – Ministerial Takeover

The scenic, scientific and recreational values of our National Parks are threatened by the new National Parks Bill, promoted by the Minister of Lands, Venn Young. As it presently stands, this Bill will abolish the current respected National Parks Act which has been in force since 1952. The Bill will take away management powers from the independent National Parks Authority, and from local Park Boards, and give them to the Minister and his Department.

## National Development Act By the Back Door?

The National Development Act was originally to apply to National Parks. Public pressure induced Parliament to stop most National Park legislation being over-ridden.

Now we find the same over-riding powers have returned in the guise of the Minister's authority in this National Parks Bill. New Zealanders have every reason to be disturbed at this about-face.

### • The Bill's Ten Major Faults •

1. The Minister could disregard the preservation ideal fundamental to National Parks (Clause 4 (2) (b) ).
2. The Minister takes new powers in a total of twenty five clauses.
3. No constraint is placed on what the Minister can authorise in a National Park.
4. The Minister could direct the Authority to approve policy counter to the principles of the National Parks Act (Clause 18). Mining, the raising of lakes such as Manapouri (for hydro-electric development), or excessive roading, or golf courses, could now be allowed by Ministerial decree.
5. A ten person Authority is to set policy, but only two of the members are required to have scientific or conservation knowledge.
6. Seven of the ten Authority members would be Ministerial appointees, yet none of these need have a concern for the protection of or an interest in the Parks.
7. User and local views could be ignored because Boards would be advisory only.
8. No attempt is made to modernise the concept of a National Park, in respect of conservation.
9. Ministerial appointment to Boards replaces Authority recommended appointees.
10. Complete lack of detail on the reserves that are to be transferred to Boards, and responsibilities and powers of the Boards and Authority over them.

## Why the Change?

Most user groups have expressed strong opposition to the Bill. The Minister claims cost savings will result. Yet he refuses to release a departmental report which would allow the public to assess this claim.

The money spent on parks, which cover 8% of the country, is small anyway – about \$4 million. This is about the same as the money currently being allocated by the obscure Marginal Lands Board, and miniscule by comparison with the thousands of millions being spent on energy projects.

### Not the Minister's

Express your concern. Contact your MP and ask him to press for the Bill's withdrawal.

Write a submission to the Secretary, Lands and Agriculture Select Committee, Parliament Buildings, Wellington, before 11 August 1980, and say why you object to the Bill.
